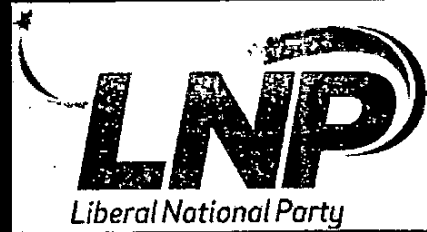

- What do you feel could have been done to make your area safer:-

- Before the flood } AS THERE WAS NOT A PRECEDENT TO THIS LEVEL OF FLOODING IN OUR AREA PREVIOUSLY
- During the flood } HARD TO ANSWER. COULDN'T HAVE IMAGINED THIS HAPPENING. MAYBE REPORTS OF HOW MUCH RAIN HAD FALLEN ON RANGE.
- After the flood } A CENTRAL NUMBER TO CALL. WE CALLED ENERGEX TO REPORT FALLEN POWERLINES ON OUR PROPERTY
- Other Questions or Statements. AT ABOUT 3:30PM ON 10/1/2011. WE SPOKE TO SOMEONE WHO HAD NO IDEA OF THE SCALE OF DAMAGE. THEY SAID THEY WOULD SEND SOMEONE TO FIX THE POWERLINES - WE HAVE POLES LYING IN THE Paddock, BURIED UNDER ROCKS & SILT, TANGLED UP IN FALLEN TREES etc. AS THIS POWERLINE IS ONLY A BOOSTER LINE, IT NOT EXPECTED TO BE REPAIRED UNTIL MAY 2011.

AT THE TIME OF THE FLOODING AT OUR PLACE IE 2:25PM ON 10TH JANUARY, WE HAD NO IDEA OF HOW WIDESPREAD IT WAS AS WITHOUT TOWN, TOOWOOMBA etc

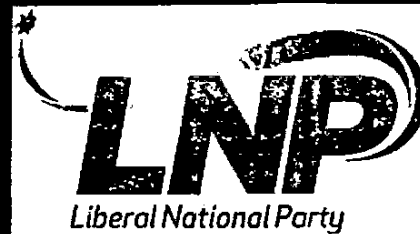
