1. Citation

This delegation may be cited as the *Water Act Delegation (No. 2) 2009*.

2. Definitions

For the purposes of this delegation –

the Act means the *Water Act 2000*

chief executive means the Director-General of the department administering the *Water Act 2000*

department means the government entity, as defined under the *Public Service Act 2008*, carrying out the function of administering the Act

An officer with a “**Level 3 Water Act Delegation Competency**” also holds both Level 2 and Level 1 Water Act Delegation Competencies.

An officer with a “**Level 2 Water Act Delegation Competency**” also holds a Level 1 Water Act Delegation Competency.

3. Commencement

This delegation shall commence on 1 July 2009 or the day of execution whichever is the later.

4. Power to Delegate

This delegation is made under section 1012 of the Act.

5. Powers Delegated

For each category listed in the schedule, the powers of the chief executive under the sections of the Act listed in row 1 are delegated to the holder of the office listed in row 2 provided however such powers may only be exercised by the holder of the office who has the Accredited Competency Requirement shown in row 3 of the category.

6. Limitations

Specific limitations of powers delegated under this instrument are, where required, outlined in row 4 of the Category.

7. Revocation

On commencement this instrument revokes the *Water Act Delegation (No. 1) 2009*.

8. **Entire Document**

The document consists of nine (9) pages including the instrument of delegation and the schedule.
