Approximately 30 businesses are currently affected by rising waters this includes the underground carpark of 'Dalby Shopping World' has been affected along with the Dalby Caravan Park which is located on the banks of the Myall Creek.
- Approximately 537 premises are without power.
- A Dalby Town water bore has also lost power that has reduced production. (Also supplemented from river pump and other bores). Town water storage is at full capacity with an expected 6 days of supply available. Adjacent to the Dalby Water Treatment plant is the Condamine River as at 10:00hrs 12/01/2011 is at a height of 10.10 metres (steady). Surat

Flood waters peaked on 04.01.2011. It is forecasted that no additional resources or resupply of food will be necessary. Once water subsides and road networks reopen, business will be as usual this is not expected before the end of the week. No damage to the shires utilities.

St George

All additional resources forecasted for have been deployed to St George. Additional staff have been identified and to be rotated by end of the week. Main body of water expected by the weekend at a level of 14m. LDMG have forecast for additional equipment and planning is in place for accommodation of evacuees at the evacuation centre. It is unknown how long water levels with remain high, but expected to be approx 1 week after peak.

Dirranbandi

Levee banks surrounding the town have been closed and heightened. Additional levee banks in sections are being created to individual premises identified as first at risk along the Balonne Minor River to the northern end of the town. Information provided by excavator operators and head hydrologist at Cubbie Station indicate that the town levee bank is about 1 metre higher than the peak river height of 5.28 metres in the March 2010 flood. If St George peaks at 1 metre higher that the March floods the river height at Dirranbandi is not expected to increase more that .3m at most (conservative estimate of rise). A road has been graded around the levee bank & inspections of the entire levee are being conducted on 05.01.2011 – regular inspections to be conducted 24/7.

Thallon

Levee bank has been secured and increased by 400ml.

SITUATION OVERVIEW

- 2. Dalby At least 200 houses and 30 commercial buildings inundated, roads damaged

 entered some buildings/rooms of the Condamine State Primary School.
- 4. Dalby South State School Evacuation centre: Children have written on the screen of a Multimedia function device. Initial estimates that the damage is approx. \$25,000.
- 5. Police Property No further damage reported.

REGIONAL REPORTS

4. Summary Of Past 24 Hours By DDMG / LDMG / Region

(Include brief details of operations; visits, etc)

1. Chinchilla LDCC activated on Wednesday 22/12/2010 due to rising flood waters in Chinchilla township. LDCC assisting members of the community and coordinating council services and clean up teams.

2. Dalby LDCC activated 0600 hours 27/12/2010 due to rising flood waters in Dalby township. LDCC assisting members of the community and attending to repairs. Also attending to clean up of Condamine.

3. Miles LDCC reactivated on 03/01/2011 to assist Dalby LDCC with re-entry into Condamine.

4. Dalby DDMG activated at 1630 hours 27/12/2010. DDCC staff are Insp Michael BIANCHI (DDC), Sgt Brett HUNTER, Sgt David TIERNEY. Summary of events:

DALBY:-

- Roads and infrastructure are also currently being repaired.
- Western Downs Regional Council Local Disaster Coordination Centre will close at COB today (18.01.11).
- As a result of moderate inundation to the Dalby Water Treatment Plant minor damage occurred and is now operating at 80% capacity.
- · Centrelink is open for normal business.
- Dept of Communities has set up a 'one stop' shop at Myall Youth and Community Neighbourhood Centre.
- Dalby DDMG meeting conducted at Dalby Police Station at 1500 hours 18/01/2011. Next meeting to be conducted at 1500hrs 19/1/12011
- Warrego Hwy Dalby to Miles open with caution with traffic controllers operating between Macalister and Warra. Traffic is alternating one direction at a time at this location.
- Moonie Hwy Dalby open to traffic under traffic control. 5t weight limit due to road surface damage and structural integrity to bridge. Further examination of bridge to be conducted by TMR once water levels drop under bridge.

CONDAMINE:-

- Condamine River at Condamine is currently <u>falling</u> and as at 1500hrs 18/01/11 is 13.60 metres and 3.50 metres over the bridge. Peaked at 14.67 metres at 1800 on 16/01/2011. The peak was 15.25 metres during the first flood event.
- There were 12 houses, 7 businesses and 2 community buildings inundated.
- As at 0700hrs 18/01/2011 there are 2 police and approximately 6 SES persons/volunteers
 remaining in town. There are 15+ businesses in town with majority all fully stocked (just on higher
 ground) including the Condamine Hotel, BP Service Station, Condamine State School and SES
 shed. There are 75+ unoccupied/insecure homes. There are 100+ vehicles parked in town on
 higher ground including large amounts of heavy vehicles, heavy machinery, and 10+ ride-on
 mowers. Most vehicles are insecure with locals leaving keys in the ignition in case they need to
 be moved to even higher ground. Police are currently 'minding' one QAS vehicle which is fully
 equipped with expensive medical equipment.
- The power to town has now been cut. SES/Police utilizing the Condamine Rugby Club House, as there is a large industrial Generator operating at that location and food and water.
- Plan of the Cleanup of Condamine currently being formulated based on critical trigger points based on the river heights. Full support offered by SDCC including use of ADF and other state resources.
- Three water treatment crew airlifted to Condamine on 18.01.11 for preliminary investigations. As most equipment was removed before latest inundation, plant is in good order.
- Advice received from ADF that at about 0800hrs a Chinook helicopter will arrive in Miles to transport equipment, residents and support workers to Condamine.

CHINCHILLA:-

- There are currently no inundated homes or business.
- Cleanup occurring with assistance of QFRS, SES etc. There is very strong community spirit and local industry has stepped up to assist in cleanup.
- Expect to have all premises restored with power as at late afternoon on 16/01/2011.

- RESUPPLY: Warrego Highway between Chinchilla and Dalby and is now passable with caution traffic controllers operating between Macalister and Warra - severe pavement damage in these sections and reduced speed zones. One lane operating at a time.
- 2 X Police officers from Logan District assisting with policing in Chinchilla.
- 2 X Police officers from Logan District now policing Condamine.

TARA:-

- Resupply of Tara is currently taking place via Goondiwindi and Moonie.
- Dept of Communities have a recovery team operating at the Tara Neighbourhood Centre.

MILES:-

- Resupply to food stores occurring by road from Brisbane.
- Warrego Highway from Brisbane to Miles is now open, with road repairs occurring btwn Warra and Macalister.

FLINTON:-

Isolated by Moonie River - 3.625 metres at 1200hrs 18/01/2011, now <u>falling</u> slowly. Re-supply of food and fuel to Flinton earlier in week by SES flood boats – no resupply concerns at this time. Inundation of premises will not occur until approx 5.5 metres – no concerns at this time.

SITUATION OVERVIEW

- 1. As at 1500hrs 20/01/11 fine weather with prediction of afternoon storms.
- There are predictions for showers and storms across the Dalby Disaster District today and possibly tomorrow.

2. Damage assessment Overview

- 1. Chinchilla Damage caused to 35 houses, roads, and approx 49 commercial buildings
- 2. Dalby At least 200 houses and 30 commercial buildings inundated, roads damaged
- Condamine (First flood) At least 42 houses and 19 business premises inundated. Water had also
 entered some buildings/rooms of the Condamine State Primary School.
- 4. Dalby South State School Evacuation centre: Children have written on the screen of a Multimedia function device. Initial estimates that the damage is approx. \$25,000.
- 5. Police Property No further damage reported.

4. Summary Of Past 24 Hours By DDMG / LDMG / Region

(Include brief details of operations; visits, etc)

1. Chinchilla LDCC activated on Wednesday 22/12/2010 due to rising flood waters in Chinchilla township. LDCC assisting members of the community and coordinating council services and clean up teams.

2. Dalby LDCC activated 0600 hours 27/12/2010 due to rising flood waters in Dalby township. LDCC assisting members of the community and attending to repairs. Also attending to clean up of Condamine.

3. Miles LDCC reactivated on 03/01/2011 to assist Dalby LDCC with re-entry into Condamine.

4. Dalby DDMG activated at 1630 hours 27/12/2010. DDCC staff are Insp Michael BIANCHI (DDC), Sgt Brett HUNTER, Sgt David TIERNEY. Summary of events:

DALBY:-

- · Roads and infrastructure are also currently being repaired.
- Western Downs Regional Council Local Disaster Coordination Centre will closed 18.01.11.
- As a result of moderate inundation to the Dalby Water Treatment Plant and damage since identified with bores Dalby is likely to remain on Level 5 restrictions for the next week. Water treatment facilities currently producing sufficient supplies of potable water to meet town demands.
- Centrelink is open for normal business.
- Dept of Communities has set up a 'one stop' shop at Myall Youth and Community Neighbourhood Centre with reduced staffing.
- Dalby DDMG meeting conducted at Dalby Police Station at 1500 hours 18/01/2011. Next meeting to be conducted at 1500hrs 19/1/12011
- Warrego Hwy Dalby to Miles open with caution with traffic controllers operating between Macalister and Warra. Traffic is alternating one direction at a time at this location.
- Moonie Hwy Dalby open to traffic under traffic control.

CONDAMINE:-

- Condamine River at Condamine is currently <u>falling</u> and as at 1400hrs 20/01/11 is 11.35 metres and 1.50 metres over the bridge. Peaked at 14.67 metres at 1800 on 16/01/2011. The peak was 15.25 metres during the first flood event.
- There were 12 houses, 7 businesses and 2 community buildings inundated.
- 7 houses and 2 community buildings not reconnected to power.
- Repatriation of the township of Condamine has commenced.
- Condamine residents from Miles and Windibri evacuation camps have returned to their residences.
- Evacuation Centre and Recovery Centre established and are operating.
- Ergon staff and electricians have restored power to majority of houses.
- One of the water pumps in the township is not working as a result unable to produce sufficient water. As it is non potable water being produced at this stage. ADF water treatment has been established and is supplementing water supply.
- 54 support staff (excluding ADF staff) currently in township. 75 ADF staff are assisting with cleanup operations.
- There are 15+ businesses in town with majority all fully stocked (just on higher ground) including the Condamine Hotel, BP Service Station, Condamine State School and SES shed.
- Condamine is now accessible from the south by road via the Leichardt Highway.

CHINCHILLA:-

- There are currently no inundated homes or business.
- Cleanup continuing with assistance of QFRS, SES etc. There is very strong community spirit and local industry has stepped up to assist in cleanup.
- Power restored to all premises except for those where no persons are home.
- RESUPPLY: Outlying properties being resupplied as requests received.
