Statement of Michael Lyons dated 10 February 2012

Statement by Michael Llewellyn Lyons, sworn on 10 February 2012

I, Michael Llewellyn Lyons of Level 15, 53 Albert Street, Brisbane, Queensland, Director, South East Queensland Water Grid Communications Unit, of the SEQ Water Grid Manager (Water Grid Manager), state the following:

- I am currently employed as the Director of the South East Queensland Water Grid Communications Unit. I have held this position since 12 August 2010.
- In this statement to the Queensland Floods Commission of Inquiry (**Commission**), as required in the letter to me dated 9 February 2012 (**Letter**), I have:
 - (a) provided all the information in my possession and identified the source or sources of that information; and
 - (b) made commentary and provided opinions I am qualified to give as to the appropriateness of particular actions or decisions and the basis of that commentary or opinion,

in relation to the matters outlined in topic 1 in the Letter.

The teleconference held at 8.30am on 10 January 2011

- At 8.30am on Monday, 10 January 2011, I attended a teleconference held in the Water Grid Manager's Emergency Management Room. I attended that meeting in my role as the Water Grid's Emergency Communications Manager and as part of my duties under the draft Wivenhoe and Somerset Floods Communications Protocol.
- In preparing this statement, I have reviewed the minutes of the teleconference contained at pages E1087-E1088 of Annexure E to Exhibit 431 (Statement of Daniel Spiller dated 13 May

2011) (**Minutes**), referred to in the Letter. I recall that I attended the teleconference but have only limited independent recollection of the discussions had during that teleconference.

- I recall that also present in the Emergency Management Room were Barry Dennien, Dan Spiller, Scott Denner and Lee Hutchison from the Water Grid Manager. My recollection is that the other participants were from Seqwater and that they participated by telephone. Besides Peter Borrows, I believe the Seqwater employees participating were Robert Drury, Paul Bird and Stan Stevenson.
- I recall that Mr Dennien and Mr Spiller were the primary participants from the Water Grid

 Manager and that Mr Borrows was the primary participant from Seqwater.
- My participation in the teleconference was primarily as an observer. I do not recall taking an active speaking role but I may have had made some, limited, comments from time to time.
- 8 My recollection is that the teleconference was primarily to provide a technical update or clarification around release rates. My interest in attending the teleconference was to gain a general overview of the then current situation.
- 9 As my role is to communicate matters to the public in an efficient and readily understandable way, I generally avoid using technical language as far as possible.

(a) Details as to any discussions involving the topic of release strategies

My understanding of the discussion in relation to release strategies was that the seriousness of the situation was escalating and that the public and key stakeholders would need to be made aware of that fact.

- I understand the references to 3.5 and 4 in the Minutes to mean an increase from 3,500 to 4,000 cumecs in release strategies, but do not have any detailed knowledge about release strategies beyond that.
- I remember the conversation around Moggill and references to cumecs, but cannot recall the specifics of these discussions apart from the fact that the level of possible releases was increasing.
- (b) Whether the terms 'W1', 'W2', 'W3' or 'W4' were used at any stage during the teleconference and, if so, by whom and in what context
- I remember that the 'W' term was used during the teleconference, but I cannot recall who used that term or in what context.
- At the time of the teleconference, and even now, the terms 'W1', 'W2', 'W3' and 'W4' were not ones which I used regularly or naturally, if at all. While I am (and was) aware that they referred to strategies used to operate the dam during flood events, I did not, and do not, have a detailed technical knowledge of each stage.
- (c) Whether I took any notes of the teleconference
- I did make brief, 'jotted' notes during the meeting but I did not keep a copy of those notes.
- (d) Whether I observed or was aware of any other person taking notes of the teleconference and, if so, who that person was
- I remember that the Water Grid Manager staff who were physically present at the teleconference had pen and paper in front of them and may have taken notes. The Seqwater staff called in by teleconference and I do not know if they took any notes.

- I do not recall who took the Minutes. However, in preparing my statement, I have identified an email from Lee Hutchison which I received at 10.21am on 10 January 2011 attaching a copy of the Minutes. A copy of that email is attached as **Annexure A** to my statement. From that email, I assume that the Minutes were prepared by Mr Hutchison.
- All the facts and circumstances deposed to herein are within my own knowledge, save such as are deposed to from information only, and my means of knowledge and sources of knowledge appear in this my statement to the Commission.
