

I, GRAHAM CECIL COOKE, Inspector for the Queensland Fire and Rescue Service and an employee of the Department of Community Safety state:

- I work for QFRS as the Area Commander Dalby and I hold the rank of Inspector. I have been employed by
  QFRS approximately 33 years. I hold Graduato Certificate in Applied Management. I also hold numerous
  qualifications as attached in GC-1. I am responsible for seven fire stations which includes maintaining
  staffing levels and response capability twenty four hours a day, seven days a week.
- My operational response is confined to larger or significant incidents including threats to human life,
  potential significant and natural disesters including floods and other either events. I have the authority for
  deployment of resources in Dalby, Cecil Plains, Tare, Jandowae, Chinchilla, Miles, and Meandarra to the
  towns and surrounding districts.
- 3. My role is to ensure that training programs are provided to ensure that the workforce has the capability, capacity and performance to be able to carry out there role, I also imbed and reinforce zero harm culture across staff and volunteers. I ensure legislative, policy and procedural requirements are applied. I prepare briefings as required for the Chief Superintendent, Director of Regional Operations.
- I recall the LDMG meeting in October 2010, which discussed the forthcoming flood season and general seasonal forecast ahead. There was an indication that there may be flooding. I attended and took notes,



- which I am able to provide, Exercise 'Orko' was table topped early in November which involved the executive of the LDMG and other agencies participating through smalls. I was not involved with the orchestration of that exercise but was aware due to emails that I was included into.
- 5. I recall discussing this topic (Swiftwater Training) in second week of December 2010 after I returned from leave, with the Captain of Dalby. Consideration was given to the technical rescue staffing west of range and the issue of not having Swift Water Rescue (SWR) teams in the Auxiliary Firefighter manned Stations across the Dalby Area. We considered up-skilling officers/members and incident management skills were looked at and reviewed.
- 6. Usually the practical exercises involving inzardous events out in the field with Ambos, QPS, local facility operators, health; this occurred between September and December 2010. These exercises provide opportunities to enhance the skills of officers and enable them to work across agencies in a multi-departmental exercise.
- 7. On the 20 December 2010 I was in the Anzac Avenue Fire Station, Toowoomba. I was made aware that a male had fallen in a creek at Dalby and a SWR Swiftwater crew had attended, however the rescue boat capsized; numerous people attended that incident.
- 8. Water subsided over the following days and we monitored weather on Websites all week. This was done through the Bureau of Meteorology (BOM); www.weather.com; Elders weather information. These sites provide information regarding the weather and rainfall forecasting. The projections indicated significant rain falls around Christmas Eve through to Saturday and Sunday. The Christmas /Boxing Day rain projections were spot on.
- 9. On Boxing Day holiday, 27th December 2010 I drove around Jondayan early morning, and then headed towards Dalby (public holiday) to essess the flood water building up.
- 10. I recall Lindsay Hackett (QPRS) rang at 0820 for an update on the Warrego Highway and offered swift water resource orew for Dalby. Wikie Creek Rural also offered assistance which I accepted however I needed RMRO Wayne Waltisbuhl to confirm this direction. He approved this request and offer of assistance.
- 11. The SWR team arrived at approximately 1100 am before the flood waters in Dalby had isolated the town.
- 12. At [145 hrs on the same day myself and the Delby Captain, Ian Tucker met with the LDMO at the Council Phood Coordination Centre. We then went and inspected the town, the water was slowly rising and evacuations were occurring during the day and evening.
- 13. One resour involved several olderly people who had been stranded in a grandstand. QPRS assisted SWR Swiftwater crow with these tasks as required.
- 14. Tasking was primarily through the Local Brandon Coordination Centre (LBCC). This was then passed on to ICC (ICC was set up 21,12,2010 at Dalby Station). My role involved coordinating crews, liaising with authorities and other services/agencies. By late afternoon the DDC from the Queensland Police

JP/Solicitor/Commissioner for Declarations:

- Service (QPS) wanted to notivate the DDMG however the majority of agency / dept representatives could not attend due to flood water between Dalby and Toowoomba. By the evening, the water had risen in areas that where it had not been expected to flood.
- 15. On the 28th December 2010 (after staying the night in town) flood waters had peaked by early morning. Rural Brigades had got into town and set up at the show grounds. The waters had cut the town in two sections; before this happened a fire Appliance and crow was located on each side of the town on the 27.12.10.
- 16. By this time the DDMG had been activated (28/12 am) and the LDMG and LECC's now reported to the DDMG. The DDMG had meetings at 0830 and 1600 and was in existence for the duration of the flooding period for one month. (ended approximately late January 2011).
- 17. At that time my role included the coordination of fire crows; welfare and safety issues; assist with evacuations; catering for crows; general community safety; equipping crows with FPB safety equipment. Rural Brigades were providing assistance throughout this period as well. I also checked with other Area stations to see how they were going, and had daily Teleconferences with the ROCC. Throughout this time I sent email messages including Siltens both morning and afternoon (I have records of these emails).
- 18. In this flood period I may had had three/four days off, but still continued with Teleconferences and other work on those days off.
- 19. On the 29.12.10 I was advised that a ring tank containing approximately 1-2 megalitres had burst, 30-40km upstream. I inspected that area and came across locals in that area actually guarding road sites where the rise in water had impacted the road and restricted the crossing.
- 20. On the 30.12.10 the Ethanol Plant was contacted and they advised that there was no one on site. Everyone from that plant had been evacuated. If anything happened on site, there was ultimately no one there to assist.
- 21. Emergency plans had been justigated for Kogan Creek power station (by the station) as it was also isolated by flood waters. That station organised to have their employees flown in and out.
- 22. On the evening of the 10.1.11 I was at home when QPRS officer Tom Dawson (AC) rang me and advised that it had been reported from Brisbane, that a 7 meter wall of water would take out Onkey and Jondaryan.
- 23. I then went out to monitor the Warrego Highway near Jondaryan (Doctors Creek), I spoke with a local traffic controller on duty there, I then watched the Oakey town area until 2300hrs that night. The floodwaters were within the banks and steady.
- 24. On the 11 January 2011, near Jondaryan, where my residence overlooks the valley (not far from the coal mine), I was outside when I heard an unusual noise. I knew it wasn't the mine so I looked up stream and then saw an immense wall of water coming through the timber and Brigalow scrub and down through the valley. The noise was the flow of the water and the traveling delnis hitting trees and other obstacles.

Witness ( Declarations:

- 25. I went inside and immediately rang QPS and people in Jondaryan to alert residents of the flood waters. I then traveled to Jondaryan where I met up with the local QPS officer. This QPS officer stayed with me for the day as I had a Nissan Patrol which enabled access to the town. We then jointly assisted people including residents that had water inundation; Truck drivers and Ergon staff were also stranded. Rural fire also assisted as they had one fire Appliance they were able to utilise.
- 26. The Issue of not having reticulated water (water treatment plant was damaged by flooding) affected the flood recovery process as more resources were needed. In order to utilize the fire Appliance you would then need a water tank to follow the Appliance to assist with washing out properties.
- 27. The situation was more challenging as there were multiple flood events and other operational incidents and therefore staffing issues like fatigue needed to be monitored. Major industry provided relief through equipment, personnel and resources and undertook significant work in the local district with regard to the recovery process; alleviating the workload on QPRS and other services.

#### QPRS Weather

28. Weather forecasts, and rainfall and river data, are monitored by me several times a day. However at my level the community briefing for weather is not applicable. The QFRS is not the lead agency. During the flood period, the weather was monitored for proactive QFRS purposes such as planning, deployment, resources and activity. The community grapovine of local knowledge also provides information and situational awareness. The Fire Warden networks are also utilized to gauge upstream conditions.

#### LDMG/DDMG

- 29. Before smalgamation each town /area had a LDMG while the DDMG was at Dalby. Following smalgamation there was only one LDMG. However in the 'outside' communities the local Emergency Services and Agency representatives were not involved in the LDMG, so they made a local committee at the local level, the Local Emergency Coordination Committee (LBCC). There is a LECC for each of Tara; Chinchilla; Dalby; Jandowse; and Miles. Reporting is through the local Service Centre Managers to the CEO to LDMG.
- 30. Regarding the DDMG/LDMG, my role is to outline ourrent resources; current deployment of crews in the towns; specialty crows; resources committed and what QFRS could do to assist or increase resources or capacity. I would represent QFRS and advise the DDMG/LDMG what we had available regarding crews and equipment. There would then be discussions on how to approach events or plan for anticipated events.
- 31. The DDMG/ LDMG could provide progress reports regarding the recovery process. Coordination; any issues reported back which could lead to additional resources being needed.

Witness (Alan, J., Special Comprision of Commissioner for Declarations:

32. The DDMG was activated around late attention on the 27.12.10. The inspector represents the QPRS; answer questions; provides information on the resources available; italsing with the DDC in coordinating the response to incidents as need be.

#### State Agenoles

- 33. I had involvement with BMQ; QAS; QId Health (vaccinations officers) QBuild; Main Roads and the Department of Communities (evacuess or general liaising), There was also interaction in the DDMG meetings; and other informal meetings.
- 34. My role with regard to those agencies was to provide information as requested from these agencies in meetings on an ad hoc basis. With regard to Main Roads meetings and discussions involved the general condition of roads for coordinating access and safety, to both QPRS transport and public. Restrictions were also put in place by Main Roads which would impact on our Appliances as the restrictions often involved weight restrictions. QPRS was often restricted as the Appliances were over the weight restriction and exemptions were not allowed at critical times due to the extent of flood damage to roads.
- 35. QBuild was also involved with the flood recovery. QPRS would firstly hose out and clean a building in proparation for QBuild to go in and take over.

### ADF/Commonwealth Agencies

- 36. QFRS also provided resources to assist in emptying Chinooks (alread) that were transporting necessary flood relief provisions and resources eg Habitat,
- 37. I would ask the ROCC where habitat or other resources were located. That information would be relayed to DDMG who would then advise the SDCC and they would organise that.
- 38. I would also provide information to Centrolink on what proporties the QFRS had washed out which would enable them to validate claims for payments.

#### Response Generally

- 39. The Communication networks worked well internally and externally. Additional equipment is required for specific incidents and local level personnel need higher level of training eg Swiftwater capability to adequately address and respond to flood incidents. We are well equipped for wild fire but less so for flood events. The lumnan resources were good however there were certain instances where the crew had to wait for other more specialized resources. We need to build on skill base of afficers regarding remote areas of SWR and include confined space training. Our officers need a broader ability as we are isolated by distance and there is often no time to wait for these specialties to arrive from elsewhere. Daiby does not have any technical operatives.
- 40. However on a whole I felt we were adequately prepared and responded to the best of our ability.
- 41. I make this statement of my own free will believing its contents to be true and correct.
